dent's Annual Report. Thanks to a very dedicated, talented, and effective Board of Directors, our chapter had another strong year in 2013-2014. This year's Board of Directors was exceptional in its energy, creativity, diligence, and can-do attitude. Congratulations and thank you to each board member for her terrific work individually and as a team member. And a special thank you to Immediate Past President Bridget O'Connell (IPP) and President Elect Laura Linneball for their hard work, sound counsel, and consistent collaboration throughout the year.

This year, we built off of IPP Bridget O'Connell's leadership in continuing to strengthen our organizational functioning. For example, we took a significant step as a chapter in engaging the administrative support services of Margaret Sanchez & Associates. Ms. Sanchez has worked for WBASNY's chapter in Rochester for ten years. Her team now also administers the WNY Chapter's membership database, manages our email communications and social media, and provides other support services. Many, many thanks to Long Range Planning Chair Karen Richardson for her assistance in guiding us through this important growth. Also, many thanks to the folks at Everywoman Opportunity Center for their handling of our membership database for several years prior to this transition.

In terms of internal organizational functioning, we also turned our attention to our use of time at our board meetings. We sought to maximize the talent in the room by moving many of the routine updates and decisions to a prior written consent agenda and written reports, thus freeing up time at the board meetings to discuss other matters. We also began each meeting with a "Mission Moment": each month, one board member shares a brief personal story regarding the importance of our mission. the nitty gritty: to move our mission of promoting women in society, particularly the law.

And finally, the Board of Directors turned its attention to a more deliberate budgeting process. We began exploring a set of processes to ensure that our revenue and expenses are in line with the best interests of our members and chapter as a whole.

In service to our membership, we focused this year on mission, mission, mission. We presented numerous events this year, all with an eye toward furthering our mission. As just a few examples, we initiated our chapter's first "book club" event by reading and discussing the New York Times Bestseller, "Lean In." Our Working Parents Committee also hosted its first Network and Play event, to allow members and potential members to engage in networking while also spending time with their children. Both events were successful inand-of-themselves, and both were well received and generated enthusiasm among members. We also sought to enhance our mission with regard to state level legislative work, by placing member Ileah Welch as Co-Chair of the statewide WBASNY Health and Reproductive Rights Committee.

In furtherance of our work with law students, UB Law Liaisons Elizabeth Kraengel and Tasha Moore initiated and saw through the creation of a new position of Honorary Law Student Board Member. We now have two law student members of the board, each to serve staggered two year terms. Congratulations Tasha and Liz on a fabulous job with this project and the many other UB Law initiatives this year.

In further service to our mission, we sought to continue to raise our profile in the community. As just a few examples, first, we continued the new format for our Installation and Awards celebration. The new format has been well received as a classy affair that keeps our Chapter on the local map as a relevant and highly regarded organization. This year we honored Congressman Brian Higgins and member Cheryl Meyers Buth – two well-deserving selections that also served to raise our profile within the legal community and in the broader community as well. Attendance included NYS Senator Tim Kennedy and a flight of judges across disciplines. Thank you Hon. Amy C. Martoche for administering our swearing-in at a board meeting in advance of the event.

To raise our profile in the community, we reinstated our legislative advocacy agenda. This Spring, we are meeting with legislators in-district to advocate for WBASNY's legislative priorities, including, but not limited, to the Women's Equality Agenda.

Additionally, thanks to Bridget O'Connell's leadership, we solicited member participation in a local legal media guide that is designed to increase diversity in media. In collaboration with the Bar Association of Erie County (BAEC) and Minority Bar Association of Western New York (MBAWNY), our members can now add their names to a list of contacts for handling media inquiries on legal matters. Already, we are seeing a diversity in the faces of lawyers providing commentary to local media.

And as a final example of raising our profile in the community, we sought and obtained an increased number of recognitions for our members through awards opportunities both within the legal community and in the greater community. Thanks to the work of Awards Committee Chair Anne Joynt and others, we placed two awards with the BAEC (Katie Baumgarten for the Civility award and Julie Loesch for the Award of Merit), and the prestigious statewide WBASNY Joan L. Ellenbogen Founders Award for Hon. Barbara Howe.

We also continued our emphasis on collaborative efforts throughout the 2013-2014 WBASNY year. For example, we continued our strong collaboration with the BAEC and the MBAWNY through co-sponsoring and co-hosting many events and initiatives. A special thank you to the recent Presidents of the MBAWNY, Stephanie Calhoun and Ericka Bennett, for their partnership. Also, a sincere thank you to BAEC President Mike Ryan for including WBASNY at the head table, at the podium, and in other prominent ways at many BAEC events. In furtherance of our collaborative efforts, we held two board meetings at community organizations, including Say Yes Buffalo, where we heard a presentation by Executive Director David Rust. We also welcomed League of Women Voters members to our viewing of Miss Representation.

We have also engaged in several special projects this year. As just two examples, first, we are serving on the Legal Taskforce for Say Yes Buffalo, which is beginning legal clinics for the families of Buffalo Public School students. Second, we have participated in the planning for Buffalo City Court Human Trafficking Court with Hon. Amy Martoche; thank you Gretchen Gonzalez for serving as the WBASNY WNY liaison.

In the meantime, we also have focused on fundamental services for our members. Thank you Elizabeth Fox-Solomon and Colleen Lamarre for getting our newsletter back on track for three high quality editions this year. We also have reinvigorated our Membership Committee; special thanks to the hard work of member Erica Rocco and we look forward to the fresh energy of members Jennifer Beckage and Elise Cassar. Thanks also to Diversity Committee Chair Lenora Foote Beavers, who arranged for us to be able to offer for our members pre-sale tickets to Hillary Clinton's speech at UB. We sold over 100 tickets through our offer – a fabulous member benefit.

In closing, I return to how I opened this report: with a sincere thank you and congratulations to this year's exceptional Board of Directors. From the beginning of the year, this year was marked with energy and creativity, such as with the successful summer Photo Scavenger Hunt designed for engaging summer and newer associates. Also, our state directors have shown a renewed energy at state level meetings and an increase in networking with other chapters. In the meantime, board members have paid special attention this year to the bottom line by confirming sponsors for events and diversifying sponsors, thereby setting us up for stability and future success. I cannot overemphasize the strength of the 2013-14 Board of Directors. Simply put, it has been a privilege and a pleasure to serve as President of the Western New York Chapter of the Women's Bar Association of the State of New York.

N MARCH 5, 2014, THE Diversity Committee of the Women's Bar Association of the State of New York along with the Eighth Judicial District Diversity Committee and the Minority Bar Association of Western New York, Inc. hosted an event in honor of Black History Month to celebrate the 50th Anniversary of the Civil Rights Act of 1964. The Hon, Rev. Darius Pridgen, President, Buffalo Common Council, delivered an inspirational speech reflecting on our progress and what is left to achieve. The following is adapted from Linneball's speech delivered on March 5, 2014, at the Black History Month Celebration 2014: Civil Rights in America: Celebrating the 50th Anniversary of the 1964 Civil Rights Act.

I'm honored and thrilled, as the President Elect of the Western New York Chapter of the Women's Bar Association of the State of New York, to celebrate with you the 50th anniversary of the Civil Rights Act.

As I was preparing to speak today, a phrase kept coming back to me: "Those who forget the past are doomed to repeat it."

I thought I should give proper attribution, so I looked it up. It turns out that many people have uttered similar quotes. I'll share just three. Edmund Burke said, "Those who don't know history are doomed to repeat it." Confucius said, "Study the past if you would define the future." My favorite is from Stephen Colbert, "There is an old saying about those who forget history. I don't remember it but it's good."

Seriously, students of history—and we all here are students of history—know that without vigilance in protecting our civil rights, these rights can ebb and flow. The Civil Rights Act protects us from discrimination in exercising our rights to vote, to use public accommodations, and to work. However, we all need to stay informed and active to ensure the Act's goals are fully realized.

There have been challenges to voters' rights. Groups even today seek to impose supposedly benign restrictions on voting. Students of history have fought back against these restrictions and upheld the spirit of the Civil Rights Act.

There are challenges to our rights to use public accommodations. As recently as last month, the Arizona Legislature passed a law that clearly violates the Civil Rights Act. Informed people stood up and spoke out against this law, and the Arizona governor vetoed the bill.

In employment, we have made great gains. We see these gains in our schools, offices, boardrooms, courtrooms, legislatures, and even the highest elected offices of the United States. But there is more to do. We need to achieve equal pay and equal advancement for all people. The Eighth Judicial District, the Minority Bar Association and the Women's Bar Association will continue to work side-by-side to celebrate, protect, and advance the rights guaranteed by the Civil Rights Act. Thank you.

Chapter of WBASNY for an indepth tour of the Graycliff Estate, designed by Frank Lloyd Wright, on July 19, 2014. Wright designed the Graycliff Estate for Isabelle R. Martin, wife of industrialist Darwin Martin. Known as "The Jewel on the Lake," Graycliff is situated on a bluff overlooking Lake Erie with sweeping views of downtown Buffalo and the Canadian shore.

Our tour will explore areas of the estate not seen on basic tours, including both floors of the Isabelle R. Martin House and the first floor of the Foster House. We will learn about the evolution of Wright's plans for Graycliff during its design in the mid-1920s and Wright's architectural style.

Judge Howe Receives Joan L. Ellenbogen Founder's Award



UR OWN SURROGATE'S COURT Judge Barbara Howe was honored at this year's statewide WBASNY Convention on June 6, 2014. The Convention was held at the Seaview Stockton Hotel and Golf Club in Galloway, New Jersey from June 5-8, 2014.

Judge Howe was the recipient of WBASNY's prestigious Joan L. Ellenbogen Founder's Award.

The award is given to a distinguished member of the bar whose acts exemplify the essence of justice, thereby demonstrating a harmony with the founding principles of WBASNY, for a singular outstanding achievement, longstanding significant involvement, or a lifetime of constancy of purpose in advancing the status of women in society and the law. Judge Howe is the first recipient of the Founder's Award from the Western New York Chapter of WBASNY.

The award is named after Joan L. Ellenbogen, the main founder and first president of the Women's Bar Association of the State of New York, who died of pancreatic cancer in 2001.

WBASNY WNY Co-Sponsors CLE on Becoming a Judge


Association of Western New York (MBAWNY), and the Bar Association of Erie County (BAEC) partnered with the Franklin H. Williams (FHW) Judicial Commission to present "Everything You Need to Know About Becoming a Judge" on May 1, 2014 at the BAEC headquarters. Hon. Rose H. Sconiers, an Appellate Division Justice and Chair of the FHW Judicial Commission, which works to promote racial and ethnic fairness in the courts, chaired the event.

Ralph M. Mohr, Commissioner of the Erie County Board of Elections, and John Postel of the NYS Commission on Judicial Conduct provided an overview of election law and related ethical requirements. Conservative Party Chair Ralph C. Lorigo, Democratic Party Chair Jeremy J. Zellner, Republican Party Chair Nicholas A. Langworthy, and Hon. Mark A. Montour spoke about the process for securing the nomination in Supreme Court. The panelists all spoke about the importance of getting involved in civic organizations and local political parties well in advance of planning a run for judicial office.

Hon. Betty Calvo-Torres (Buffalo City Court), Hon. Frank Caruso (Supreme Court), Hon. Sheila A. DiTullio (Erie County Court), and Hon. Craig D. Hannah (Buffalo City Court) discussed making the ballot in City, County, and Family Courts. MBAWNY President Ericka N. Bennett moderated a lively and frank discussion about the time and cost involved in running a judicial campaign--eight to nine months of campaigning and costs ranging from \$40,000 for a local uncontested race to \$250,000 for a contested Supreme Court race--as well as the panelists' personal paths to the bench.

The event ended with a discussion of the appointment process for non-elected judgeships, which was moderated by WBASNY WNY President Elizabeth Harned. Chief Judge William M. Skretny of the U.S. District Court, Western District of New York, Magistrate Judge Leslie G. Foschio, and NYS Court of Claims Judge Michael E. Hudson provided insight into the application and appointment process for their respective positions.




